

# Trump Clean Energy Business Impact Tracker Toplines

Trump's policies are creating chaos across the clean energy sector, threatening or canceling clean energy projects that are driving new investments and creating new jobs across the country. Since Trump's election, companies have announced that **64** clean energy projects are being threatened, delayed, or canceled, representing **\$57.06 billion** in investment and **42,493 announced jobs**.

## Overall Toplines

Since Trump's election, clean energy companies have announced at least:

- 64 clean energy projects are threatened, delayed, or canceled.
- \$57.06 billion in new investments have been delayed, threatened or canceled.
- 42,493 announced jobs have been threatened or eliminated.

## State Spotlight

### Arizona

In Arizona, companies have announced that 4 clean energy projects have been threatened, delayed, or canceled since Trump's election, impacting \$3.61 billion (\$3,610,000,000) in investment (\$3,610,000,000) and 7,235 jobs.

### Georgia

In Georgia, companies have announced that 2 clean energy projects have been threatened, delayed, or canceled since Trump's election, impacting \$5.43 billion (\$5,425,540,000) in investment and 1,311 jobs.

### Michigan

In Michigan, companies have announced that 6 clean energy projects have been threatened, delayed, or canceled since Trump's election, impacting \$14.22 billion (\$14,217,700,000) in investment and 2,288 jobs.

### Nevada

In Nevada, companies have announced that 1 clean energy project has been threatened since Trump's election, impacting \$2 billion (\$2,000,000,000) in investment and 5,000 jobs.

### North Carolina

In North Carolina, companies have announced that 1 clean energy project has been threatened since Trump's election, impacting \$275 million (\$275,000,000) in investment and 200 jobs.

## Pennsylvania

In Pennsylvania, companies have announced that 1 clean energy project has been threatened since Trump's election, impacting \$182.6 million (\$182,600,000) in investment and 551 jobs.

## Texas

In Texas, companies have announced that 2 clean energy projects have been threatened or canceled since Trump's election, impacting \$29 million (\$29,000,000) in investment and 58 jobs.

## Wisconsin

In Wisconsin, companies have announced that 2 clean energy projects have been threatened or canceled since Trump's election, impacting \$2.5 billion (\$2,500,000,000) in investment.

## Methodology

The clean energy business impacts tracker tracks clean energy projects or companies that the press has identified as delayed, threatened, or canceled since Trump's election. The tracker includes projects or companies that directly cite Trump administration actions as a reason for their closure as well as projects that are canceled, delayed or threatened without specifically citing Trump administration actions.
