FACT SHEET: Trump's Unfolding Energy Crisis

Household electric bills are up [10 percent nationally](#) since Trump took office, and are **poised to spike even further**. In July 2025, the Trump administration and congressional Republicans passed the “One Big Beautiful Bill Act,” or the *Republican Rate Hike*. The bill is already raising utility costs and costing jobs by cutting cheaper, cleaner energy sources to give a tax break to oil and gas billionaires. **Donald Trump and Republicans are creating a self-inflicted energy crisis**, sending utility costs through the roof, closing down factories, and making us more dependent on foreign oil, all while polluting our air and water.

Over [64,000 jobs](#) have already been lost or stalled in the clean energy sector since Trump's election. With rising energy demand driven by AI and extreme heat, gutting clean energy is already taking critical production offline and increasing costs for consumers. Americans across the nation are already seeing their [utility costs skyrocket](#). The *Republican Rate Hike* will increase the average family's energy bill by [\\$130 annually](#) by 2030 and [\\$170 annually](#) by 2035, with some states expected to see their bills rise by [over \\$400](#) per year in the next decade.

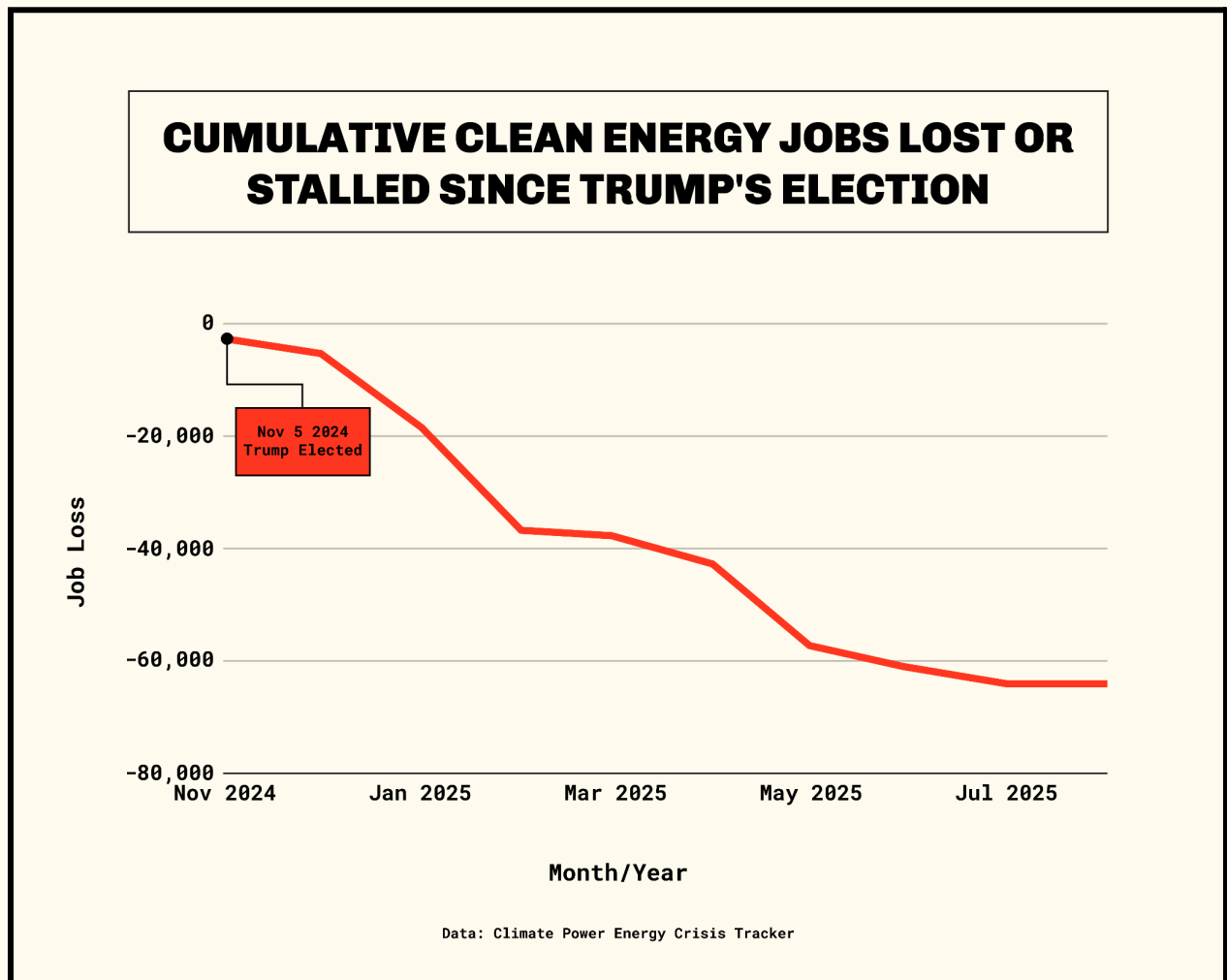
- **Trump's Energy Crisis is already here.** Companies are canceling energy projects and laying off staff because of the administration's policies, as utilities are hiking rates because of increasing energy demand from data centers.
- **64,148 clean energy jobs** have been lost or stalled between Trump's election in November 2024 and August 10, 2025.

TRUMP'S ENERGY CRISIS IS DRIVING JOB LOSSES ACROSS THE U.S.

- **64,148 energy jobs** have been lost or delayed between Trump's election and August 10, 2025. Companies have canceled, delayed, or laid off staff at 123 energy projects in 33 states, representing over \$33.87 billion in lost investment.
- **60 percent** of listed projects have been canceled since Trump's election.

TRUMP'S ENERGY CRISIS IS DISPROPORTIONATELY HURTING CONGRESSIONAL DISTRICTS REPRESENTED BY REPUBLICANS.

- **56 percent** of lost or stalled jobs are located in congressional districts represented by Republicans in Congress.
- **52 percent** of canceled projects are located in congressional districts represented by Republicans in Congress.

- **The clean technology and battery sectors** have seen the highest number of cancellations.
- **The wind sector experienced the highest job losses** since Trump's election, driven by the administration's animosity toward the technology.

TRUMP'S ENERGY CRISIS IS REDUCING ENERGY SUPPLY

- **13,939 megawatts** of planned energy generation have been lost due to energy projects that were canceled or delayed since Trump's election.
- **Over 8.4 million homes** in the U.S. could be powered by canceled or delayed generation energy projects since Trump's election.

ENERGY BILLS ARE ALREADY SOARING, AND TRUMP'S ENERGY CRISIS WILL MAKE IT EVEN WORSE

Household electric bills have [increased by 10%](#) nationally since Trump took office, while natural gas prices rose 56%. In the year-over-year comparison between May 2024 and May 2025, [residential electric prices](#) rose 6% and [residential gas prices](#) rose 8%.
